Preamble:

This Memorandum of Understanding (MOU) outlines the terms and conditions of collaboration between Chamarajanagara University and the European International University (EIU-Paris) to foster educational exchange and cooperation for the advancement of teaching and learning.

### Article 1: Purpose and Objectives

1.1 The main objective of this MOU is to promote educational cooperation and enhance the quality of teaching and learning through the mutual sharing of resources and expertise.

### Article 2: Collaborative Programs

2.1 Chamarajanagara University and EIU-Paris agree to collaborate on the Teaching for Learning (TFL) program. Chamarajanagara University will provide the TFL program to all teachers of Chamarajanagara University and beyond at no cost.

2.2 Participants of the TFL program who choose to obtain an EIU certification upon successful completion will be charged a certification fee as determined by EIU-Paris.

### Article 3: Credit Transfer and Equivalent Degrees

3.1 All graduates of Chamarajanagara University across various faculties and programs will be eligible for 100% credit transfers towards equivalent programs at EIU-Paris.

#### Article 4: Duration and Termination

4.1 This MOU is effective from 8 September 2023 and shall remain valid for a period of 5 years, unless mutually extended by both parties.

4.2 Either party may terminate this MOU by providing written notice to the other party 90 days prior to the intended termination date.

#### Article 5: Miscellaneous

5.1 All collaboration activities under this MOU shall be subject to the laws and regulations of the respective countries.

5.2 Any modifications to this MOU shall be agreed upon in writing by both parties.

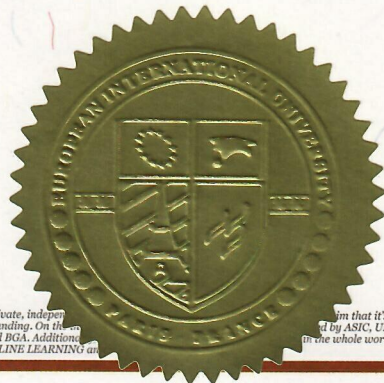
